Dear Andrew,

This is a similar approach to how you are handling things today.

There would be two (2) ODF-2000 models for the GSF machines (one-each). There would be an ODR-2000 for the COS and the GTP (one footprint), an additional ODR-2000 for the GHD/GSF, and finally the last ODR-2000 for the GTP (this would have additional capacity for an additional machine).

I have used the A-Smoke or ODR style units for the oil for the proper filtration efficiency.
